



Also, speaking at the launch was Ms Sonia Foster, Deputy Permanent Secretary, Ministry of Industry, International Business, Commerce and Small Business Development, who stated that the investment from ACL represented the company’s confidence in the Barbados economy and sent a message that, “Barbados is indeed open for business”.

Mr Nicholas Mouttet, President and CEO of ANSA McAL Barbados Ltd, reiterated the Group’s commitment in building the economy in Barbados.

“Since the investment in Standard Distributors in Barbados about 55 years ago by the ANSA McAL Group, the company continues to invest heavily here. In fact, it is our second largest geography in terms of our investment in the region and is extremely important to us. We have been able to open three retail stores in Barbados in the last 20 months, despite challenging times.” Mr Mouttet went on to state that, “Four months ago, we opened up another Standard Store in Bridgetown in Norman Centre and we will continue to look for opportunities to invest in Barbados.”

The intension of ANSA Coatings Ltd is to bring a new dimension of coatings products and services to the buoyant commercial area of Wildey, Barbados. The ANSA McAL Group Mid-Year Financial Results for 2016



On Thursday 11th August, 2016 the ANSA McAL Group declared profit after-tax \$352.8 million for the first six months of this year, an increase of less than one per cent compared with the same period in 2015.

The Group's unaudited results showed a modest improvement over 2015. Revenues increased by \$16 million to \$2.88 billion while the Earnings Per Share (EPS) improved by 1.7 per cent to \$1.78 for 2016 compared with \$1.75 in 2015.

Chairman and Chief Executive of the ANSA McAL Group, Mr. A. Norman Sabga, attributed the Group's positive results despite "contracted market activity," to its conglomerate model. "I always talk about the conglomerate model, the resiliency, being in so many different areas and the balancing act of one sector being up and the other being down. It has worked well for us. Not everybody has the ability to manage multiple

organizations in multiple disciplines in different jurisdictions." Mr. Sabga said.

The Group Chairman went on to talk about the Group's brewery acquisition in Florida. "The Florida Indian Beer River Brewery company is the third largest brewery in Florida. In the month we have been in operation, we have already seen a significant improvement in the results of that company. This particular transaction was as exciting one for us. That makes four breweries in the Group," he said. Asked if a devaluation of the TT\$ would help the manufacturing sector Mr. Sabga stated, "The answer would be yes, but it would affect trade. One would go up and one would come down."

Results were disclosed at the Stockbrokers Meeting at the 10th Floor of the TATIL Building in Port-of-Spain.

ANSA Motors First on the Market To Introduce OEM CNG Trucks



ANSA Motors was recently appointed sole authorised distributor for the internationally renowned Freightliner brand. Diamond Motors a division of ANSA Motors hosted a media launch at its FUSO showroom, Port of Spain to showcase the three Freightliner models. On display were the Columbia CL 120 (Tractor), the M2 106 (26ft Chassis) and the M2 112 (CNG model).


Speaking at the launch Mr. Rishi Basdeo, General Manager at Diamond Motors said, “The Freightliner M2 112 (CNG) model can be used for industrial and commercial use. We believe this model will grow in popularity due to Government’s emphasis on the use of CNG. Having both a commercial and a passenger OEM CNG vehicle in our portfolio is important because of Government’s very strong initiative to migrate passenger and commercial vehicles from high diesel usage to CNG. ANSA Motors was the first to bring in a passenger OEM CNG vehicle in the form of the Honda City CNG as well as the first in the commercial side, with the Freightliner M2 112 model.”

Mr. Jamie Cohen, Managing Director at Mercedes Benz/Freightliner Latin American and the Caribbean, described Trinidad and Tobago as one of the largest markets in the Caribbean.

Regarding increased market share in heavy duty truck sales, Mr. Basdeo explained that Freightliner and Fuso Trucks are both part of the Daimler Trucks International portfolio.

“It’s also a market for trucks and especially now with the CNG initiative, it’s a pioneering initiative that we are very glad to support. We have been doing it in the North American market and going into Latin America and the Caribbean, it’s most important for all of us, both from the technology and also from implementing something that’s ecologically friendly, reducing carbon footprint and really helping the world. So it’s really important,” he concluded.





ANSA Merchant Bank holds the success of the Private-Public Partnership (PPP) model

ANSA Merchant Bank Limited (AMBL) believes that the private-public partnership (PPP) model for project development has significant merit in advancing the goals of national development. Recently, this model was proved sustainable in the development of the Barbados Water Authority (BWA) building which demonstrated the ability for both private institutions and the public sector to work together to deliver tendered projects on time and as budgeted.

In an interview with the Business Guardian, Mr. Gregory Hill, ANSA Merchant Bank - Managing Director stated, “The BWA building project had been on the cards for over 25 years. Prior attempts to get it done proved unsuccessful. The completion of this project on time and on budget was really a landmark achievement that validates the PPP model and we were able to deliver a world class facility to the Barbadian government because of our ability to execute and because of our understanding of how to make PPP work in the Caribbean context.”

“For two years in a row we have held an investor forum in Trinidad to keep Barbados in touch with the local investing community. We gathered together major institutional investors and held open discussions on the economic developments taking place in Barbados.”

Mr. Hill added that the PPP model is apt for deployment in Trinidad given the declines in energy prices and the ability for state and financial institutions to work together to develop projects and share risks. He said, “There are a lot of lessons we can take from our Barbados experience and carry over to the T&T context. Given declines in fiscal revenue, the government is charged with the task of finding creative ways to finance projects, and this is where PPP can play a role in advancing development initiatives.”

He also noted that the bank has been one of the more active players locally advocating the use of PPP in project development. He further explained that locally, the bank is currently exploring a few PPP projects at the moment. Mr. Hill highlighted that one of the keys to success of any PPP arrangement was discipline by all parties involved to see projects through to completion – on time and within budget.

AMBL has a long history of doing business in Barbados. Through its sister company, Consolidated Finance Company Limited (CFC) the bank has been involved in providing financial products to the Barbadian public for many years. Its involvement in a private-public partnership of this kind therefore was a natural follow on from its involvement in providing project financing in Barbados.

Getting to Know

Teresa White - Media Sector Head and HR Director

“Being known for being truthful is the basis of your credibility.”

YOU ARE THE FIRST FEMALE SECTOR HEAD IN THE GROUP. HOW DO YOU FEEL ABOUT THAT AND IS IT A BIG DEAL FOR YOU?

I am both honoured and humbled to be the Sector Head of Media. Media is a groovy sector. But having said that, we are at a difficult point in our history. As Guardian Media ventures into its 100th year, we have to transform the quality of our content, adjust to our commercial realities and adapt to digital delivery - all at the same time. I see my role as guiding Guardian Media through that transition, removing blockers, providing commercial oversight and applying my change management expertise in support of its new Managing Director, Lucio Mesquita.

These are the thoughts that tend to occupy my mind when I think of being a Sector Head. So, clearly it is a big deal - a big task and significant accountability - so much that being the first female Sector Head is rarely something I dwell on.

Further, I do work in a very supportive context. The Group has invested heavily in Executive coaching, so expert advice from Bob Dantowiz at JMW is a phone call away. Both the Group Chairman and Deputy Chairman will always make the time to talk me through leadership or commercial questions. If I need assurance on a management process or control, Bernadine Sammy - Fuentes, our Head of Audit, wastes no time in performing the necessary checks. And, of course, there is my trusted, wise and (sometimes brutally) honest colleague, Frances Bain - Cumberbatch, our Group Head of Legal and Corporate Secretary.

YOU APPEAR TO BE A NATURAL BORN LEADER, BUT REALLY HOW DIFFICULT IS IT TO JUGGLE TWO DEMANDING PORTFOLIOS - I.E. SECTOR HEAD & GROUP HR DIRECTOR?

It's gratifying to be told that I am a natural born leader, but I am naturally very absent-minded. I have learned to juggle my priorities through being very consciously organized and having Sandra Rezende who sustains my good intentions and work habits.

A few years ago, the Group was lucky enough to have the famous writer, Malcolm Gladwell, address its Executives. One of the qualities he attributed to successful people was that they actively compensate for their weaknesses as opposed to capitalizing on their strengths.

So, this is how it works:

- 1. My team is my backbone. I have high standards and I build my team carefully; I am hard on people who don't deliver and I am even harder on myself when I fall short.*
- 2. I only promise what I can deliver and I ensure that my deliverables have stretch to tax and excite me and the team.*
- 3. I then organize myself and my team so that delivery is completed within a few days before the promised deadline, thereby allowing all the necessary quality checks and iterations to happen smoothly and without stress.*
- 4. I love my lists - everything is written down in a very visible place and ticked when completed.*

WHY IS THE MEDIA SECTOR RELEVANT TO THE GROUP AND HOW EXCITING IS IT GIVEN ADVANCED/MODERN TECHNOLOGY BEING UTILIZED IN THE MEDIA LANDSCAPE TODAY?

Media puts us at the coal face of what is happening and there is a huge buzz with that. That alone makes it an attractive and rewarding business to be in.

We are also going through huge disruption in the traditional media landscape: Guardian Media is moving to Digital First. This means that not only our technology is evolving, our content and news have to be delivered differently. There needs to be more focus on the brevity and pithiness of our copy, the catchiness of our photographs, and the easy availability of short illustrative videos.

WHAT PIECE OF ADVICE WOULD YOU GIVE TO A FEMALE TRYING TO EMULATE YOU?

The first thing I would say is: don't. Be true to yourself.

The advice that I would give generally to women is not to hide your light, not to be afraid to speak out for what you think is right and not to define yourself through the definitions of others - define yourself.

There is advice that I would give to all - men and women; Never cover up, always fess up and then clean up. We all make mistakes and we will get things wrong. It is how you handle these things that shows your metal. Being known for being truthful is the basis of your credibility.


Rayanna Richards – Champions Graduate CDC/Carib Brewery Limited



Tunapuna Piarco Regional Corporation, the newest addition to “Glass Works” Recycling Initiative

On Sunday 28th of August 2016, Carib Glassworks Limited (CGL) extended its glass recycling initiative, “Glass Works”, to the Tunapuna Piarco Regional Corporation (TPRC) at the Eddie Hart Savannah carpark. CGL unveiled a glass recycling bin during the 2nd Annual 5k Walk / Run Aerobics Burn Out event held by the Fun Runners Club (who call the Tacarigua area home). The event promoted a healthy lifestyle and was a great avenue for Glass Works to be promoted.

Mr. Damian St. Hill, Sales & Marketing Manager at CGL, said that “CGL produces, on average, 20 million containers per month for both the local and regional markets. On an annual basis, the total weight of glass we produce and sell into the local market is 40,000 metric tons. We get back a little less than 10% of this quantity. That is appalling.” In an effort to collect a greater portion of the glass that it produces, CGL has been promoting glass recycling through Glass Works.

Also present for the day’s activities was the Chairman of the TPRC, Mr. Edwin Gooding. He, along with the President of Fun Runners Club – Mr. Kenneth Wafe, participated in the ribbon cutting ceremony with Mr. St. Hill, officially revealing the new glass recycling bin.

The placement of the GlassWorks bin at the Eddie Hart Savannah aligns well with the goal of the TPRC in encouraging persons to separate their recyclable waste from their rubbish. CGL has expressed its willingness to work with other regional corporations and state entities in ensuring that recyclable glass containers are not discarded irresponsibly.

ANSA McAL US Inc provided new clothing and shoes for the children of Cottage 25, which houses 14 boys between the ages of 10 and 17 years old.


